ORDER

To smoothen the supply chain process during the peak season and in order to avoid the immediate problem of supply in the market the department has decided to take the following actions till further orders with respect to the ESCIMS System:

1. **Receipt of Stock against IP:** All stock will be received through the web interface available in the system using "select all" option. All bond inspectors have been explained about this. This will ensure speedy unloading of stock and will be similar to existing process.
Breakage can be deselected from the web interface and handled separately at a later stage as per existing process.
2. **Corporation Purchase Order:** Corporations will be supplying the details of their requirements in excel sheet to IA on mail id- excisesupport.delhi@nic.in. IA will ensure entry of data in ESCIMS and generate PO by next day.
3. **Transport Permit:** Facility to print TP is provided on the BWH user interface to facilitate printing. Only one copy of the TP will be printed and copy will be retained for office copy purpose. The TP shall be approved only upto 3 pm
4. **Dispatch against TP:** Dispatch against TP will be without scanning. Instead as per current practice, case bar code number will be manually noted as against the current practice of hologram details. The noted bar code details may be collected manually by IA subsequently for their completion of dispatch activities in the system. This will however in no way affect the dispatch of stocks against TP. This will ensure speedy dispatch of stocks to retail outlets including HCRs similar to existing process.
5. **Hotel, Clubs and Restaurants and Pilot Vends:** All HCRs to receive 2D stock normally as per existing process without receiving in ESCIMS. Similarly all pilot vends will also receive and sale stock without scanning as per their existing practice. Stocks shall continue to be maintained in their respective stock registers at all retail outlets manually.
6. **2D Barcode on Beer Bottle:** The brewery will paste the 1D and 2D Barcode on the cases till further orders. The IP will be continued to be issued from ESCIMS.
