## ORDER

Whereas, the Excise licenses in the form of L-1, L-1F and L-2 (Draught Beer), Retail Licenses (L-6, L-7, L-8, L-9, L-10, L-11, L-23), HCR Licenses for service of liquor "on" the Licenses (L-15, L-16, L-17, L-18, L-19, L-20, L-28, L-29), L-30 (Personal Individual License), premises (L-15, L-16, L-17, L-18, L-19, L-26, L-28, L-29), L-30, (Personal Individual License), PL-10, L-10, L-

And whereas, in order to ensure smooth and uninterrupted supply of authorized liquor in Delhi, the above licenses were renewed / extended up to 30.09.2021 with the prior approval of Competent Authority subject to payment of proportionate pro-rate license fee vide order No.F.(9)/Policy/Extn. Excise/2020-21/304 dated 10.06.2021.

And whereas, the Government of NCT of Delhi has approved the new Excise Policy 2021-22, which is being implemented and the new retail licenses are scheduled to start from 17.11.2021.

Now therefore, in order to ensure smooth transition from the old Excise licenses to the new licenses for the year 2021-22 and to ensure the supply of bonafide liquor to the residents of Delhi, it has been decided that: -

- a. All wholesale licenses i.e. L-1/L-1F and L-2 (Draught Beer) licenses will continue to operate beyond 30.09.2021 till 16.11.2021 i.e one day prior to the scheduled date of commencement of business for new licenses granted in form of L-7Z subject to payment of pro-rata license fee under Rule 34 of the Delhi Excise Rules, 2010.
- b. All Government liquor vends in form of L-6/L-6FG/L-6FE will continue to operate beyond 30.09.2021 till 16.11.2021 i.e one day prior to the scheduled date of commencement of business for new licenses granted in form of L-7Z subject to payment of pro-rata proportionate license fee. This will ensure that the supply of liquor is maintained in Delhi during the transition period.
- c. All Government Country liquor vends in form of L-8 will continue to operate beyond 30.09.2021 till 31.03.2022 subject to payment of pro-rata proportionate license fee.
- d. All Government Country liquor vends holding license in form of L-14 (beer license) will continue to operate beyond 30.09.2021 till 16.11.2021 i.e one day prior to the scheduled date of commencement of business for new licenses granted in form of L-7Z subject to payment of pro-rata proportionate license fee.
- e. All HCR licenses for service of liquor "on" the premises (L-11, L-15, L-16, L-17, L-18, L-19, L-20, L-28, L-29) will continue to operate beyond 30.09.2021 till 16.11.2021 i.e one day prior to the scheduled date of commencement of business

for new licenses granted in form of L-7Z subject to payment of pro-rata proportionate license fee.

- f. All M&TP licenses L-4, L-5, L-25, L-26, L-34, L-35, P-2, P-3, P-4, P-5, P-6, DD-9, DD-10, DD-11 and Authorization Permit (AP) will continue to operate beyond 30.09.2021 till 31.03.2022 subject to payment of pro-rata proportionate license fee.
- g. All CSD licenses (L-23/L-23F) and L-30 (Personal Individual license) will continue to operate beyond 30.09.2021 till 31.03.2022 subject to change of duty rates for CSD under Rule 153 as and when the new amended rules come into effect.

Concerned branches shall issue separate fee order wherever required.

This issues with the approval of the Competent Authority.
